Foreword

Mission is the purpose of the Church. Inaugurated by Jesus coming to bring the good news (particularly to the poor), it is given to us in his Great Commission to make disciples of all nations, baptising and teaching them all that he has commanded. As the Mission Planning Action Group this has been on our minds as we have sought to create a mission plan for our Presbytery: how are we to be disciples of Jesus telling, teaching, tending, transforming and treasuring in our local communities?

Our planning needs to be honest about our context. There is nothing to be gained by denying that we have less resources, fewer ministers, too many ageing buildings, strained finances, and often tired office-bearers struggling to maintain structures designed in another age. Some will say that this plan is really all about cuts. Well, yes, in a sense it is. But as we seek to make those inevitable cuts, how do we prune in a way that best shapes us for mission? How do we wisely deploy what we do have in a way that honours the calling God has given us? How do we ensure sustainable congregations, with appropriate buildings, who are able to focus their strengths on seeking a future and not simply on preserving a past?

Our Presbytery planning is also defined by decisions of our General Assembly. We are constitutionally committed to a territorial ministry where every community is served by a parish church. We are committed to the pooling and sharing of our resources (through Giving to Grow) with a particular priority for our poorest communities. The plan must reflect this. It must also reflect the decision of the General Assembly to allocate 59.5 posts as our Presbytery's current share of ministries available to our national Church. These are givens that our committee has had to work with as we have wrestled with our mission.

However, our most critical decision, endorsed by the Presbytery, was that planning should start from below, and not from above. We wanted local congregations to cluster together to shape their local mission. For that reason, Presbytery approved a formula – based on population and congregational finances – that would allocate part of our 59.5 posts to each locality. This allowed local discussions to have a realistic picture of the resources available to them. We then invited you, who know your communities best, to plan the mission and future shape of the Church in your area. It's been hard work, often involving difficult – sometimes frustrating – conversations, but we are grateful for all that you have invested in it. Your submissions have been vital, and often positively inspiring.

Our committee's role has been to shape these various local submissions into a coherent plan for the whole Presbytery. We've had to test what was sent, and sometimes fill in the blanks. We've had to keep in view our responsibility to present a plan that might be agreeable to the Presbytery, but also might pass the subsequent scrutiny of the General Assembly's Committee and the General Trustees. That means sometimes – although not usually - we have been unable to recommend all that local conversations might have wanted. We are aware that this will disappoint.

Time has been a challenge. We have asked you to conclude discussions, and make responses, in what has often seemed unreasonable timescales. We are aware of that. However, the General Assembly set a two-year target and, due to delays caused by the formation of this Presbytery and the resignation of the earlier Planning Group, we are already almost nine months beyond that national deadline. Timing has been hard for all of us.

We now offer you our draft plan. It's not perfect. It includes some very hard choices. It may not always seem inspirational. Sometimes it is simply the art of the possible. It will certainly need to evolve over time (but that's always been the intent). However, we do believe, as a group, that we now offer to you the best that we can give, within the constraints that we had, to shape the mission of our Church.

The Committee are grateful to the Presbytery staff, who have worked on this beyond all reasonable expectations. Responsibility for this plan (and its inevitable shortcomings), however, lies entirely with us, and not with them.

Humbly then, we commend this document to you for your prayerful deliberation, as we commend our Presbytery and its mission to our gracious God.

Section 1:

The Mission Narrative of the Presbytery of Forth Valley and Clydesdale

Welcome

Welcome to the Presbytery Mission Plan for the Presbytery of Forth Valley and Clydesdale (FVandC). This plan will detail the Presbytery Mission Plan (PMP) for the 120 congregations from the most northernly point of the Presbytery in the parish of Airth, north of Falkirk, to the southernmost point of Upper Clyde within Dumfries & Galloway Council, from its most easterly point at Black Mount near Scottish Borders to its most westerly point within Strathaven next to East Ayrshire. The Presbytery covers roughly 900 square miles mainly within the council areas of South Lanarkshire, North Lanarkshire and Falkirk. It covers rural places and urban places. It is home to both places of affluence and places of poverty as an everyday reality.

Mission Narrative

History

The Presbyteries of Hamilton and Lanark agreed to come together to form a new Presbytery in February 2021, and a task group with representatives from each Presbytery was created. The Presbytery of Falkirk representatives joined the task group in March 2021.

The Presbyteries of Hamilton and Lanark were permitted to create a new Presbytery together on the 1st of January 2022 by the General Assembly of the Church of Scotland 2021.

The Presbyteries of Falkirk, Hamilton and Lanark agreed on a structure document separately in November 2021. This structure document was further agreed upon by Presbytery of Forth Valley and Clydesdale (FVandC) and the Presbytery of Falkirk, at the first meeting of the new Presbytery in February 2022 (held concurrently with a meeting of the Presbytery of Falkirk). At the Church of Scotland General Assembly 2022, the Presbytery of Falkirk was permitted to join the Presbytery of Forth Valley and Clydesdale, formally joining at the June 2022 meeting of the Presbytery.

Missional stance

The Presbytery stated how it wished to be within this variety of lives, experiences and skills.

Supporting congregations to share the Good News of Jesus Christ through working with each other, working for each other and being with each other.

- We work with each other by providing resources, knowledge and training based on learning and receiving from each other and also being accountable to each other.
- We work for each other by doing the things Presbytery can do in order to free up congregations to do what they are energised to do.
- Being with each other means knowing each other, listening to each other, learning from each other and supporting each other collaboratively.

We encourage and support congregations to provide:

- Opportunities for worship, fellowship, the teaching of the Christian faith, the enriching of community life, ensuring that the views of the local Church are heard on matters of wider concern;
- Pastoral care, advice and support to people in each parish.

This structural approach is inspired by an analysis of Jesus' time in the Gospel narrative. Rev Dr Sam Wells found that Jesus spent 90% of his time being with, 9% of his time working with, and only two weeks working for.² In agreeing on this strategy, Presbytery said that FVandC should primarily be with, often work with and rarely take the position of work for.

Being with is about "...accompanying people while they find their own methods, answers, approaches - and meanwhile celebrate and enjoy the rest of their identity...",³ it is fragile, risky and honest within a very bruising PMP process.

Working with is where Presbytery seeks to use of everyone's skills and gifts in working together. It is a space of reciprocal relationship around a common goal (never doing something for someone they could properly do

Working for is where Presbytery does things and makes the congregation's life better.⁵ By doing things a congregation cannot

This structure offers three critical practical and theological anchors for Presbytery to embody. Being with, Working with, and Working for.

The Presbytery seeks to be with people. To be alongside and go through life with people. The Mission Planning Action Group (MPAG) was drawn from among us, members of churches within the presbytery. We are Elders, Ministers of Word and Sacrament, Assistant Ministers, and Readers. MPAG members work through this process as part of their own congregation, working out what it means to follow Jesus while this process is ongoing. The MPAG of the Presbytery is alongside this; it experienced where it has cost; some committee members have seen their congregation unite, and some committee members have seen their buildings categorised for disposal. Some committee members have even seen their congregation embark on a dissolution process. They brought this to the Presbytery, knowing this process will change all of us; some will be relieved, some will be angry, and some will be speechless. The MPAG members lived in this; they pray because of/despite this; and share this experience with readers.

The Presbytery seeks to work with people. To encourage people to work with this process. to encourage people to come together and plan for the future of the space, time and place which they inhabit. The process asked for people to talk to each other. To dream with each other and also to commit to each other. This process was a significant commitment, and where people found this process hard, the Presbytery committed to providing facilitators to work with people on this journey of seeking God and reshaping the church to join God there.

The Presbytery seeks to work for people. It aims to work in places where the task is too challenging for people. The MPAG found itself taking some decisions which the Kirk Session did not suggest, could not suggest or offered something other. This is not an easy or light responsibility. It is also a hard place to be when congregations provide little guidance. Yet it is a place often the MPAG has found itself. In presenting this to the Presbytery for their consideration and approval, the MPAG were conscious of the strain of this task and its responsibilities. It has sought expert advice on various matters, as per the normal practice and procedure of the church. In particular around statistical analysis within Giving to Grow figures and population data. The Presbytery Mission Officer and Buildings Officer offered helpful advice, and the Presbytery Clerk and Depute offered timely legal advice.

This structure commits the Presbytery to work in a way in which subsidiarity is key. The lowest court should take the decision or discuss any matter where possible. This means that local congregations should be able to take decisions which affect them (wherever possible). As the saying goes **Nothing about us, without us, is for us**.⁶ While Presbytery is committed to this, it also has constraints placed upon it by General Assembly. This will be expanded upon later, but it is significant to note that the Presbytery, as a higher court than Kirk Sessions, interrogated and discussed every and all suggestions which were put to it before deciding if things were to be endorsed and then presented to the Presbytery for their consideration; or whether to present something else contrary to the Kirk Session decision.⁷

Mission Plan Team, Nov 2021-September 2022

FVandC attempted a Presbytery Mission Planning process as its first joint piece of work with representatives from each of the legacy Presbyteries. This effort was unsuccessful. This effort was foundational as it asked congregations to speak to each other and consider the future shape and resourcing of the Church of Scotland with the Presbytery. This work was useful and created a base of knowledge and relationships which shaped the work of this plan. We thank those involved in that process.

Mission Plan Action Group (MPAG)

Following the resignation of the Mission Plan Team (MPT) a new team was set up. Presbytery tasked the Resourcing Mission Team, through its nomination process with seeking names for Presbytery's approval, to form a new Mission Plan Action Group. Nominations were circulated for approval at a meeting called for that purpose, including

identifying an independent convener, from a neighbouring Presbytery. The Mission Plan Action Group (MPAG) is made up of 11 presbyters and an independent convener, was approved by Presbytery at a pro re nata meeting called on 25 October 2022, and began work immediately. The group has met nearly every week or more frequently since then.

It was recognised that, having regard to the strict time constraints and volume of work facing MPAG, that a full-time person was required to assist in the delivery of the Mission Plan. Approval was obtained to recruit a suitable person, and despite two recruitment adverts being placed along with the canvassing of suitable candidates, no applications were received.⁸ In order to meet the deadlines for delivery, Presbytery staff were called on to provide invaluable assistance to MPAG, which they did in addition to their regular job.

At a meeting called for the purpose, Presbytery approved a "bottom up" process, in which each congregation was asked to form a cluster with others that they would want to work with. This process of working together created a common vision of what mission could be, based on what assets congregations contributed to the conversation.

The MPAG developed a Mission Plan Cluster Form for clusters to complete together showing the plan for the mission of the new group. Within the Cluster Mission Plan form, local parties could express the logic and principles behind their decisions. Facilitation was offered for clusters who requested it. Later the MPAG also developed two sub-groups, one group looking at drafting the Presbytery's Mission Plan itself and one group focused on buildings.

While many congregations returned to clusters that had been recommended by the previous committee, starting clustering quite quickly, some congregations found the process of creating or entering a cluster troublesome and were offered significant support from members of the MPAG and Presbytery staff.

The missional nature of responses was broad. They ranged from challenging, experimental, risk taking to a replication which seeks to maintain what exists.

Completed proformas were read by at least two members of MPAG and feedback was provided, asking for clarity and further details around key areas of their mission plan and form of adjustment. However for some congregations where clustering had been a very difficult process the proformas were not submitted in time for additional detail to be sought. For clusters who could not produce an agreed proforma each congregation was asked to submit comments as to where they felt the discussions so far had led. Those outwith the clustering process were asked to contribute ideas in a similar manner to those clusters who could not submit agreed proformas.

The proformas from every cluster, together with any subsequent revisions, were then thoroughly examined by the drafting group and summarized for approval by MPAG. At the same time the buildings group were reviewing and discussing areas where buildings issues were emerging. MPAG members were encouraged to read the cluster form and responses to feedback [if any] of every cluster when drafting or buildings discussions came to MPAG for discussion.

Whilst the subsidiarity approach depends on local decision making, rather than Presbytery control, MPAG was not bound by those local decisions. Every cluster submission and its summary were reviewed by MPAG, in corroboration with neighbouring cluster[s], and most, but not all, were accepted as being plans that would deliver mission effectively and locally. Where buildings issues had not been clearly resolved the buildings group then did more detailed work to clarify this element of each plan. These decisions were then brought to MPAG again to approve.

The final plan in its entirety was reviewed by MPAG before being sent to Presbytery for approval.

National Constraints

MPAG asked for mission plans to be developed by clusters. This created a process of local decision making. However, MPAG was steered also by a wider context of constraints set nationally by the General Assembly of the Church of Scotland. These national constraints were the groundwork of all plans set by FVandC Presbytery. Therefore, the MPAG could not accept all proposals presented to it.

Presbytery Mission Plan Act, Act 8 2021, as amended

This major piece of legislation asked every Presbytery to consider and plan for reshaping and resourcing the Church of Scotland within the Presbytery.¹⁴ To achieve these changes, several tools were offered to help presbyteries in this process. The Act and its supporting tools created constraints for any process the Presbytery created.

Marks of Mission

During the clustering process clusters were asked to complete a proforma, the first stage allowed each congregation to initially examine what they currently do for each mark of mission, this was then shared with the other congregations in the cluster which allowed them to see similarities and to see where areas, when combined, could flourish. The plan was then grown from a combined summary of what the cluster could do under each mark of mission.

While most churches will do work that embodies all five marks of mission across church life, certain marks of mission take more prominence in mission plans than others due to their unique missional activities. The Presbytery has a variety of expressions of Church and all 5 marks of mission are evidenced across the breadth of the plan. 15

The five marks of Mission are

- To proclaim the Good News of the Kingdom.
- To teach, baptise and nurture new believers.
- To respond to human need by loving service.
- To seek to transform unjust structures of society, to challenge violence of every kind and pursue peace and reconciliation.
- To strive to safeguard the integrity of creation and sustain and renew the life of the earth.

Code of Practice

Presbytery must prioritise mission through the PMP process. No area of church life is exempt. The code of practice helps show the importance of the difference in locational, cultural, social and theological factors as missional drivers. Across Presbytery there is sufficient coverage of all aspects of the code of practice, although it is not entirely balanced.

The code of practice headings are.

- Communities, (CofP I).
- Ecumenism, (CofP 2).
- The Poor, (CofP 3).
- Whole People of God, (CofP 4).
- Congregations, (CofP 5).
- Mixed Economy, (CofP 6).
- Financial Responsibility, (CofP 7).
- Buildings, (CofP 8)¹⁶

Centrally funded posts allocation

Forth Valley and Clydesdale Presbytery were allocated 59.5 FTE centrally funded posts. This figure is given annually within the Faith Action Plan Leadership Team reports to the General Assembly. The centrally funded posts within FVandC Presbytery will be filled by either inducted Ministers of Word & Sacrament (MWS), and/or Ministries Development Staff (MDS) posts which may include Assistant Minister posts. The Presbytery agreed to a process of allocation making use a combination of population data and Giving to Grow assessments to apportion ministry to each of the three areas (West, East and South) and thereafter, smaller clusters.

Weightings given by the General Assembly

The plan seeks to apply these consistently with how they were given by the General Assembly of the Church of Scotland. The plan does not seek to adjust these.

Priority Areas

Priority Areas have accorded double weighting for population. This can allow for additional staffing (usually an MDS post) to be deployed in Priority Areas to develop work with the congregation and community. We have 6 congregations in Presbytery who are in priority areas. A congregation or building in a priority area can be identified throughout the Mission Plan from their name being in a purple shaded box.

Rural areas

It has been identified that there are significant allowances which need to be made by the rural context. The legacy Presbytery of Lanark has an urban/ rural area status which allows a 1.5 x population figure weighting. This weighting is applied to congregations within the former Lanark Presbytery. A congregation or building in this category can be identified throughout the Mission Plan from their name being in a green shaded box.

Temporality

The Presbytery Mission Plan has to be evaluated every 12 months by Presbytery and then concurred with by national partners. In a separate process, General Assembly-appointed bodies confirm the centrally funded posts allocation for the Presbytery every year at the General Assembly. This means that the plan is the plan for today, but it will evolve. It will potentially need to change in responses to national constraints within the near to medium term.

Additional Posts

Following the clustering process and after decisions on congregational adjustment, including Dissolutions, were made an additional 1.5 FTE ministry allocation was available. In order for Presbytery to fulfil the instruction of the General Assembly of 2022 which stated that former Presbytery areas which had received a rural weighting should be allocated the number of posts that was calculated for at that time. A 0.5 FTE additional post is reserved by the Presbytery to support ministry and mission in the former Presbytery of Lanark area with the nature of said deployment to be determined in a future process at an appropriate point during implementation. The decision was made to allocate the remaining 1.0 FTE allocation to those clusters most adversely affected by mathematical rounding in the cluster allocation process. Two clusters therefore were awarded an additional 0.5 FTE post each (see pages 42 and 56).

For the avoidance of doubt

The following areas of definition and clarification are offered for readers.

Names of congregations

The nomenclature used in this document is the naming system used by the Church of Scotland for statistical analysis and financial matters. This naming system may differ from the way in which congregations refer to themselves.

Parish Boundaries

The proposals do not contain any proposals for parish boundaries being changed. All maps in this document are for illustration only and do not mandate or suggest an external boundary change.

Where a union is recommended, the new union would maintain the existing boundaries at the outer edges and, in this way, would not change the parish boundaries with other charges, and all adjustments would be internal.

Team Ministry

Where a union has been suggested in this plan, with two or more inducted MWS, the plan understands this will need a basis of team ministry included in the basis[s] of adjustment. Likewise, where a Team Ministry is suggested, a basis of union is included in the basis[s] of adjustment.

A simple way to understand it is that a Basis of Union describes how the Kirk Sessions and Charities unite to create something new. A basis of Team Ministry describes how inducted MWS come together to create something new.

Where a staffing compliment of one MWS and one or more MDS workers for a charge is included without a consideration of a Basis of Team Ministry by a cluster. Presbytery should, through its implementation team, consider whether individuals should be called and/ or appointed on the Basis of a Team Ministry.

Building Categorisation

The only eligible buildings for classification were ecclesiastical buildings. There are three forms of this within the Presbytery

- I. Church (main place of worship)
- 2. Other churches or halls within a separate building but still housed on the same site as the first building.
- 3. Other churches or halls within a separate building outwith the site of the first building.

Any other buildings Kirk Sessions have responsibility for are separate from this categorisation, such as manses or charity shops.

The plan categorises the buildings into three classes. Two classes are specified in the Presbytery Mission Plan Act (A & B); the other is not (B*).

- A The building is " ... to be retained beyond the five years from the date at which the Mission Plan is approved or annually reviewed". The annual evaluation of the Presbytery Mission Plan will review building categorisation. Any subsequent changes will be proposed to the Presbytery for their decision. Spending rules on the building would be as usual Presbytery procedures. If it is discovered a significant amount of money is needed to be spent on a building to make it adequate, Presbytery may use this new fact to propose a categorisation change.
- B The building is " ... to be sold, let or otherwise disposed of by a specified date which is within five years from the date at which the ecclesiastical building is first categorised as (b)". 18 This will mean no spending on the building will be authorised by Presbytery beyond wind and watertight repairs.
- B* There are three variances of B*, which the plan uses. Where the plan classes a building as B*, there is a specific B* statement that relates to these variances.
 - The first variance of B* is where there is evidence that the local parties will have a complicated conversation and decide on a main place of worship before the first annual evaluation. Until the Presbytery approves that decision, only wind and watertight repairs can be made on the buildings.


- The second variance of B* is where specific Kirk Sessions are required to detail and propose works on particular buildings. Plans for reconfiguration should be presented by the Kirk Session to the Presbytery, along with full costings and financial statements of affordability by the congregation, by the date specified. Should the plan be approved by Presbytery in consultation with the GT's then the building would be reclassified at the next annual review.
- The third variance of B* is where the plan allows a pioneering approach to church. This outworking is to be reviewed by year three of the plan. The B* categorisation pertains to the timing of the project review. If it is discovered a significant amount of money is needed to be spent on a building to make it adequate, Presbytery may consider a categorisation change.

Dates

The MPAG has generally specified that any B classifications are disposed of at the date of the associated adjustment. In exceptions, the MPAG has set a particular date beyond this norm. Any specified date is the last day of the month.

West Area

Introduction

The west area of the Presbytery comprises the largest population area including the large towns of East Kilbride, Hamilton, Coatbridge, and Motherwell as well as many smaller towns and villages. The border of the area is observable at the north-eastern end by the division between Coatbridge and Airdrie, beyond this the border is around the M8, the border with the south area is more ambiguous and does not conform to a major piece of geographic infrastructure.


Historically Hamilton and Motherwell were ancient settlements dating back to Roman times and medieval times. The area of East Kilbride village dates to Neolithic settlements, however it was significantly developed as a new town under the Clyde Valley Regional Plan in the 1940s to deal with Glasgow's population overspill.

The west area of the Presbytery is mostly an urban and suburban area, including some areas with great levels of deprivation and some areas with significant wealth. The local infrastructure routes via both road and rail makes this area popular for commuters working in Glasgow City Centre and the rest of the central belt. This location leads to a significant investment in the west area of new housing, creating communities on the outskirts of towns, where churches do not currently have a physical presence.

Clusters

At the start of Mission Planning every congregation were asked to form into clusters of two or more congregations. Most clusters that have formed are of geographically adjacent Parishes that have much in common. This plan will consider within the West area two cross area clusters, one that is a non-contiguous, cross border cluster of South and West areas, and one contiguous cross border cluster the West and East areas.





Please note: The adjustment of dissolution is used sparingly. The plan uses this reluctantly, although in some cases congregations have chosen this adjustment. Where dissolution is suggested, the churches concerned cannot remain on their own (which is true of many churches within Presbytery). However, in these cases, either

East Area

Introduction

The East area is made up of the charges from the Airdrie area to the top north and east section of Presbytery. This is not clearly marked for the most part as the division between Coatbridge and Airdrie, the division between Airdrie and Kirk of Shotts and a for a small part by the M8 motorway. The main towns of Airdrie and Falkirk can date their history back to 1141 for Airdrie, and at least to a roman fort along the Antoine wall in the case of Falkirk. The East area is governed in civil law by part of North Lanarkshire Council and also most of Falkirk Council.


Historically Airdrie was known for its weaving trade, while Falkirk was once an industrial area based around Iron Works, also cotton mills, coal mines and foundries. In the East area these have disappeared over the last hundred years and the only heavy industries that remain are to be found along the Forth in Grangemouth and Bo'ness and are mainly petrochemical related. Within Airdrie historic immigration from the Highlands and Ireland in the mid-1800s coupled with large unemployment post war, created a town where industrial estates of small companies provide a significant amount of employment. Mass employment opportunities centre around employers such as the Albert Bartlett and Son factory in Airdrie, the INEOS petrochemical plant in Grangemouth, and the NHS via the Monklands hospital in Airdrie and the Forth Valley Hospital, based in Larbert, just outside Falkirk. Within the East area there is also a significant farming community.

The area is dominated by good commuter links, via road and rail to the major cities and towns of the central belt, including Edinburgh, Glasgow, Stirling, Paisley, Motherwell and Hamilton. This has led to the East area becoming a commuter zone, with many people travelling for work, east and west to the major cities of Edinburgh and Glasgow.

Clusters

As the new planning group started its work, every congregation was asked to form into clusters of two or more congregations. Most clusters that have formed are of geographically adjacent Parishes that have much in common. The non-contiguous cross border cluster between the West and East areas will be considered by MPAG within the West Area.



South Area

Introduction

The south area of the Presbytery comprises the largest geographical area, with the lowest population density. It comprises a mix of urban towns, market towns, country towns, rural villages, former mining communities and widespread small settlements. The borders of this are ambiguous and not easily observable. The area is governed administratively mainly by South Lanarkshire Council, and to a small extent, by Dumfries and Galloway Council.

The main industry in these places were historically centred around mining, heavy engineering, and steel production. Scottish gold mining is a surprising but small element for the south, area, within the main production of coal throughout the south area and neighbouring areas of Ayrshire and Lothian. Nowadays major industry is absent from this area. Generally, the large employers are council based, but mostly, small size businesses are the norm. The creation of Windfarms in the South area has created jobs, and generated some income for communities within the windfarm's locality.


The South area is well supported by the M74 which runs south to north across the region, as such, it has become part of the commuter belt for both Edinburgh and Glasgow and many of the towns and villages have a sense that they have become dormitory communities. Although the area is large, most of the population is split between the 4 main towns of Lanark, Carluke, Wishaw and Strathaven, all of which are in the northern part of this area.

There is significant history of Christianity in the area with worshipping communities going back to the 10th century. Many places have a strong Covenanting history. For many of the country towns and villages, churches provide a key facility where communities can come together and where voluntary organisations can access spaces to provide additional community services.

Clusters

As the new planning group started its work, every congregation was asked to form into clusters of two or more congregations. Most clusters that have formed are of geographically adjacent Parishes that have much in common. The South area includes one non-contiguous, cross border cluster of South and West areas, this cluster will be considered by MPAG within the West Area.

Appendix B – Methodology

The MPAG started its work in November 2022. This is a record of its method of mission planning until the Presbytery meetings to accept the Mission Plan in late September/early October 2023.

Work of previous Mission Planning Team.

The members of MPAG were encouraged to consider the wide range of submissions and initial thoughts of the former Mission Planning Team.

Clusters

Every congregation within the Presbytery was invited to form a cluster.

"Accept the term "Cluster" to refer to a group of current congregations agreeing to meet together to form a local mission plan, in the weeks between the Presbytery meeting of 10th January and 31st March 2023, with the minimum number of congregations in a cluster being two, possibly more commonly three or four, but maybe a larger number depending on local circumstances."

The Presbytery approved this deliverance on 10th January 2023.

This deliverance applied to every congregation within Presbytery. The MPAG took specific steps to aid congregations in this clustering process for Presbytery Mission Planning. The method for each situation was different from the others. Therefore, MPAG developed three distinct methods of engagement with -

- 1. congregations within the cluster system.
- 2. congregations outwith the cluster system.
- 3. Local Ecumenical Partnerships (LEPs).

Method of engagement one-congregations within the cluster system.

MPAG discussed and confirmed every suggestion of a cluster made by a congregation of the Presbytery. Most congregations were able to form clusters successfully and engage with each other and with MPAG from within the cluster process. Presbytery asked each cluster to fill out a "Cluster Mission Plan form".¹⁹

Presbytery informed each congregation that if any constituent part within a cluster asked for a facilitator for the conversation, one would be provided. MPAG delivered facilitation in two main periods. The initial cluster formation period and the period covering congregational requests were made further along the clustering process.²⁰

At the end of the specified time for clustering, the Presbytery instructed clusters to return the agreed sheets to the MPAG.

Also, the Presbytery instructed each constituent Kirk Session to send an Extract Minute of the Kirk Session discussion and document approval.

- Most extract minutes indicated an approval.
- Where MPAG did not receive Extract Minutes, or MPAG received Extract Minutes that indicated disapproval of the plan, the MPAG considered these. The MPAG either suggested a different outcome in the Cluster Mission Plan from the locally agreed outcome or MPAG asked the cluster to re-examine the issue.

Throughout this process, MPAG has held a tension between a commitment to the local decision-making process and the constraints placed upon the Presbytery by a higher court that introduces a constraint upon what can be agreed by the MPAG.

- If Cluster Mission Plan Forms were submitted by the 31st March 2023, the MPAG reviewed and discussed the cluster submission and suggested feedback which was written, approved and sent to all constituent parties within the cluster. Cluster responses to feedback were collected and read by MPAG. This information informed the creation of the cluster sheets.
- If Cluster Mission Plan Forms were not submitted by the 31st March 2023 the MPAG could not offer feedback on any submission. The Cluster Mission Plan Form was read and discussed by the MPAG.

Some congregations found the cluster discussion too hard for them. And as such, the cluster broke down. Presbytery met with reps and/or Kirk Session[s] in these situations as appropriate. In a few cases, this led to Kirk Sessions submitting individual suggestions to the MPAG of what shape and resource for mission in their areas would

entail. The MPAG discussed these suggestions and used them to inform the recommendations in the cluster sheets (which are appropriately noted).

Method of engagement two-church outwith the cluster system

Several congregations were unwilling or unable to join a cluster. This may have been for a variety of reasons. The main two reasons were able to be categorised as -

- Some congregations were unwilling to engage in the process philosophically or theologically.
- Some congregations were unable to engage in the process due to relationships with others.

Between January and March the MPAG tried to engage with each unclustered congregation through the following steps.

Step one

MPAG, had an initial meeting between the congregation representatives, MPAG members and Presbytery staff members. The discussion covered the viability of the congregation as an independent entity. Options for getting into a cluster including: clustering with unclustered congregations; getting into an existing cluster; or, the Kirk Session making an individual suggestion to the MPAG.

Please note - In two cases, MPAG explored the option of forming a cluster with a congregation outwith the Presbytery. These outwith Presbytery approaches were rejected.

Please note - In one case, the Kirk Session was unable/unwilling to engage with MPAG to facilitate this meeting.

Step two

Kirk sessions were encouraged to engage within the task of finding a cluster. Ministers / Interim Moderators were in regular contact with Presbytery staff. Presbytery staff facilitated conversations with neighbouring clusters if asked by congregations.

Please note - several congregations entered existing clusters as part of this process.

In two cases, an additional meeting with the Kirk Session (without a minister/interim Moderator) took place. As a result, one congregation was allowed to enter the clustering process, whereas the other remained unclustered, engaging in the remaining process.

In one case, a meeting with the Kirk Session (without the minister/interim Moderator present) and a separate meeting with the Minister/Interim Moderator (without the Kirk Session present) occurred. As a result, the congregation decided not to engage any further with the MPAG.

Step three

After the date of submission of the Cluster Mission Plan Form, MPAG contacted churches that remained outwith clusters to alert them to the end of the clustering process and arrange a formal meeting with the Kirk Session and board (where appropriate) without the minister/interim Moderator present, and, a separate meeting with Minister/Interim Moderator without the Kirk Session present. At this meeting, representatives of MPAG and staff invited each Kirk Session to make individual submissions of the most missional suggestion that the Kirk Session could make. The MPAG had two suggestions as a result of this. MPAG endorsed one Kirk Session missional suggestion while it declined to support the other Kirk Session missional suggestion.

Where the MPAG endorsed the Kirk session missional suggestion, a space within the Mission Plan was created for that suggestion.

A Presbytery-approved dissolution proceeding started when the MPAG declined to support the Kirk Session missional suggestion.

Method of engagement three-Local Ecumenical Partnerships (LEPs).

LEPs are agreements between several denominations to deliver ministry within a place jointly. The Church of Scotland is a partner within two LEP expressions within the Presbytery. As part of the LEP commitment, the Church of Scotland has signed up to commit 1 x 0.5 FTE post from the centrally funded posts allocation of the Presbytery.

The MPAG did not consider the status or review of the LEPs of the Presbytery as LEPs are not governed by the Presbytery nor the General Assembly. A different ecumenical body governs LEPs and the constitution they operate from is different to the Church of Scotland form. Financially, they do not participate in the Giving to Grow system of the Church of Scotland.

Falkirk: Bainsford has applied to join the Falkirk: Grahamston United LEP. MPAG has heard of local conversations and the expounded desire of both charities to become one. Presbytery is invited to vote for this as the appropriate form of adjustment for Falkirk: Bainsford.

Additional allocation of centrally funded posts.

Beyond the individual clustering arrangements, MPAG was able to distribute any additional posts within the Presbytery. A General Assembly section of deliverance in 2022 created a constraint that meant that within the 1.5 FTE to be allocated, the Former Presbytery of Lanark congregations should receive an additional 0.5 FTE Centrally Funded Post allocation. The MPAG was mindful that the Presbytery had agreed to round any allocation to the nearest 0.5 FTE centrally funded post allocation.

MPAG decided on a mix of 4 principles to create a decision matrix. The principles agreed upon were

- a. clusters that have been significantly rounded down
- b. the geographical needs of larger areas and
- c. areas where territories of proposed dissolved congregations lie
- d. Not to award additional posts to the CA cluster.

MPAG used the principle of awarding more staffing to clusters rounded down by the calculation of centrally funded post allocation agreed upon by Presbytery in January 2023. This principle gave a mathematical model for the allocation of staffing. And its figures had been independently verified. This Plan will take the two most rounded-down clusters by the mathematical model and add 0.5 FTE to their total.

The MPAG considered clusters where dissolution would affect the population figures used by the calculation. However, MPAG found any disadvantage would not change the top two clusters affected by rounding after carrying out this arithmetic.

The awards were to the two clusters that had been rounded down the most by the calculation used by the Presbytery to allocate Centrally Funded Staff

- Increasing cluster E7 staffing allocation by 0.5 FTE.
- Increasing cluster EK2 staffing allocation by 0.5 FTE.

Further, the Plan allocates to the former Presbytery of Lanark to fulfil its General Assembly instruction.

• The Plan provides a staffing allocation of 0.5 FTE to the former Presbytery of Lanark congregations to support ministry and mission. The exact nature of the deployment will be determined by the appropriate Presbytery body in the future.

There were 138 responses from congregations within the presbytery; some congregations responded more than once. A small number of congregations received follow-up emails or phone calls.

23 December 2022 Email send by MPAG to all congregations.

MPAG wrote to all congregations inviting congregation to create or join a cluster of other congregations by 25 January 2023 or sooner. The email also asked congregations to consider if facilitation was needed. Any constituent part of the cluster could send a request to the Presbytery if they felt facilitation was required.

10 January 2023 – Presbytery meeting.

Details of this meeting can be found in Appendix D

25 January 2023 – emails received by MPAG.

On the date set by MPAG for the receipt of cluster suggestions

- Congregational responses suggested 29 clusters.
 - One hundred congregations were involved in clustering.
 - o Twenty congregations were not clustered.
- MPAG approved all clusters suggested.

Cluster formations were sent by MPAG to an independent external statistician to verify figures, specifically population and giving to grow figures, and also the calculation which created an allocation of centrally funded posts for the cluster.

10th February 2023 - email congregations by cluster.

Confirmations emails were sent to 31 clusters. Each cluster was issued with,

- Confirmation of an allocation of centrally funded posts (independently verified).
- Blank Cluster Mission Plan form to return by 31/03/2023,
- A table containing the allocation of centrally funded posts for the whole presbytery divided into three areas, East, South and West.

Seven congregations sought assistance from a facilitator representing seven clusters. A further seven clusters requested facilitation as conversations developed.²¹

MPAG worked with congregations outwith clusters. MPAG representatives met with them and negotiated on their behalf. Over this time, from February to the end of March, most congregations were able to join with existing clusters or form their own clusters.

2 March 2023 Presbytery meeting

31 March 2023 Cluster forms returned to MPAG

Seventeen Cluster Mission Plan forms were returned to MPAG by this date. Presbytery instructed that each Cluster Mission Plan Form should be accompanied by an Extract Minute by each constituent Kirk Session indicating their approval before the MPAG considered the clusters form fully submitted.

- There were 33 clusters, including 114 congregations.
 - Three congregations remained outwith a cluster.
- Two congregations outwith a cluster were invited to submit individual Kirk Session recommendations to MPAG.
- Two congregations sought dissolution.

25 April 2023 Email from MPAG to all congregations

- There were 34 clusters including 115 congregations.
 - o 22 Cluster Mission Plan forms were returned to MPAG by this date.

10 May 2023 Email to the MPAG

One congregation outwith a cluster decided to not engage any further with MPAG.

14 June 2023 Email from MPAG all congregations

All clusters who had submitted proformas by the I May 2023 were sent a feedback email. The email gave feedback and asked for clarification on a variety of points.

- MPAG considered 25 Cluster Mission Plan forms.
- There were four clusters that requested assistance in responding to the clarification points.

All clusters that had not submitted either Cluster Mission Plan forms or responses were notified that the final date for submission was 30 June 2023.

- Nine clusters had either begun later or needed further assistance through facilitation that did not receive feedback or a request for further clarification.
- MPAG gave one cluster an extended deadline of 17 July because of specific circumstances.

30 June 2023 end of Cluster Mission Plan form stage

MPAG received 31 Cluster Mission Plan forms by this date.

17 July 2023 end of feedback and clarification stage

With the Submission of the outstanding Cluster Mission Plan form 32 Cluster Mission Plan forms were received by this date.

- Six congregations were invited to make an individual Kirk Session submission to MPAG as the process of clustering had not worked well for them.

20 July 2023 end of feedback and clarification stage

17 clusters made submissions to clarify MPAG feedback points. (24 clusters were given feedback or asked for clarification).

2 September 2023 Presbytery meeting

11 September 2023 Meeting with MDS staff

MPAG representatives met with Ministries Development Staff (MDS) to indicate that their current role[s] did not feature in the Presbytery Mission Plan. However, in line with the HR policy of the Church of Scotland, there will be an effort to job-match any newly created MDS posts with existing staff. The meeting also conveyed the support available from Presbytery and HR in the intervening period.

CONTEXT FOR THE ROLE:

The objective of the Presbytery of Forth Valley and Clydesdale is 'supporting congregations to share the Good News of Jesus Christ through working with each other, working for each other and being with each other'.

The Presbytery of Forth Valley and Clydesdale is in the process of completing Mission Planning. It has become apparent that to meet the requirements of the process there will be much adjustment throughout the Presbytery. This includes a significant number of unions, local mission churches, and closures. There are three legacy presbyteries (Falkirk, Hamilton and Lanark) that have come together in one large Presbytery, changing the dynamic of working for all constituent parts. As this is an area of change that can be particularly difficult to navigate, the hope is that this individual would be able to inspire and encourage others to engage with mission planning.

The individual would enable the implementation of the Presbytery Mission Plan by working with Kirk Sessions, Ministers, and the Mission and Care Team (Mission Implementation Group).

MAIN DUTIES

Coordinate meetings with Kirk Sessions and/or Ministers to negotiate the change outlined in the plan in

- area groupings or within parishes.
- Working in conjunction with the Presbytery Clerk and office staff, co-ordinate the implementation of the plan with the ability to prioritise key areas.
- Provide guidance and support for congregations uniting whether in vacancy or with ministers in post and provide information to the Clerk for completion of Basis of Union documentation.
- To work with the Buildings Officer and the Mission Officer on feasibility studies where buildings are to be determined A or B on a mission basis.
- Working with the Mission and Care Team:
 - Enable Stipendiary and non-stipendiary Ministers, MDS, Readers and Kirk Sessions and other relevant parties, to develop team structures that enable clear job descriptions for other roles such as Readers, OLM, MDS and locally appointed posts, primarily within the larger parishes.
 - Support the creation of Local Leadership Teams within Local Mission Churches established within the plan.
 - Provide updates for the Presbytery and request resources and training through the Mission and Care
 Team around the implementation and fulfilment of the Mission Plan.
 - o Develop a process for the Annual Review of the Presbytery Mission Plan.
- To contribute fully to the Faith Nurture Forum appraisal process.
- Undertake such other duties as may be required from time to time by the Presbytery.

OUTCOMES

- Working as part of the team to enable, as far as possible, the implementation of the Mission Plan.
- To develop those areas of the plan where interim steps are needs.
- Build trust between the Presbytery and the congregations.

Parish Profile

The new Presbytery of Forth Valley and Clydesdale, previously Falkirk, Lanark and Hamilton presbyteries, covers an area from Airth in the north to Elvanfoot in the south, Bo'ness in the east and Strathaven and East Kilbride in the west. The Presbytery includes urban areas such as Airdrie, Coatbridge, East Kilbride, Hamilton, Motherwell, Motherwell alongside a significant rural area within South Lanarkshire. The area covers most of South Lanarkshire, North Lanarkshire and all of Falkirk Council areas

At the present time, the Presbytery includes 120 congregations within 98 charges holding more than 160 individual buildings. The Mission Plan will reduce these numbers, to 59.5 FTE ministry posts. It is envisaged that this will include a mix of MWS and MDS; and current estimates look likely to reduce the number of ecclesiastical buildings by around 47%.

The Presbytery Staffing Team includes the full-time Presbytery Clerk, Depute Presbytery Clerk (7 hours), Mission Officer, Education Training and Development Officer, the Buildings Officer and an Administrator (15 hours) and three part time Chaplains who each work on average 24 hours per month. Much of the committee work of Presbytery is overseen by two teams – the Mission and Care Team and the Resourcing Mission Team. The Mission and Care Team includes the remit for implementation of the mission plan along with ministries, pastoral care, world and community issues. The Resourcing Mission Team covers finance, property and stewardship as key areas.

- 3. Note with concern that several congregations had not submitted an agreed proforma document by the end of May 2023 and declare that the clustering process ends on 30 June 2023 after which date the Mission Planning Action Group will determine the shape of ministry and congregational life within these clusters as part of the whole Presbytery Mission Plan.

- 4. Remind all congregations of the previous instructions of Presbytery to engage with the those involved in Mission Planning and therefore have as much input into the process as possible.
- 5. Agree to progress towards the Dissolution of the congregation of Cleland and instruct the Mission Plan Action Group in conjunction with the Clerks to make arrangements to draw up, consult on and agree the draft basis of Dissolution with the Kirk Session and Congregation and bring a report to the Presbytery on 2 September 2023.
- 6. Agree to progress towards the Dissolution of the congregation of Carriden and instruct the Mission Plan Action Group in conjunction with the Clerks to make arrangements to draw up, consult on and agree the draft basis of Dissolution with the Kirk Session and Congregation and bring a report to the Presbytery on 2 September 2023.
- 7. Agree to progress towards the Dissolution of the congregation of Larkhall: Trinity and instruct the Mission Plan Action Group in conjunction with the Clerks to make arrangements to draw up, consult on and agree the draft basis of Dissolution with the Kirk Session and Congregation and bring a report to the Presbytery on 2 September 2023.
- 8. Agree to hold three meetings for the Specific Purpose of approving the Presbytery Mission Plan in the autumn of 2023 with each meeting dealing with one of the three geographic areas of Presbytery (East, South and West).
- 9. Agree that for the purposes of the Mission Plan Process the East area of Presbytery shall consist of the congregations of Airdrie: Cairnlea, Airdrie: Clarkston, Airdrie: High, Airdrie: Jackson, Airdrie: New Monkland, Airdrie: St Columba's, Airdrie: The New Wellwynd, Airth, Blackbraes and Shieldhill, Bo'ness: Old, Bo'ness: St. Andrew's, Bonnybridge: St Helen's, Bothkennar and Carronshore, Brightons, Calderbank, Caldercruix Longriggend, Camelon, Carriden, Chapelhall, Denny: Old, Denny: Westpark, Dunipace, Falkirk: Bainsford, Falkirk: Grahamston, Falkirk: Laurieston, Falkirk: St. Andrews West, Falkirk: Trinity, Grangemouth: Abbotsgrange, Grangemouth: Kirk Of The Holy Rood, Grangemouth: Zetland, Greengairs, Haggs, Larbert: East, Larbert: Old, Larbert: West, Muiravonside, Polmont: Old, Redding and Westquarter, Slamannan, Stenhouse and Carron with a total allocation of 19 FTE Ministry posts.
- 10. Agree that for the purposes of the Mission Plan Process the South area of Presbytery shall consist of the congregations of Biggar, Black Mount, Cairngryffe, Carluke: Kirkton, Carluke: St. Andrew's, Carluke: St. John's, Carnwath, Carstairs, Cleland, Coalburn and Lesmahagow, Crossford, Dalserf, Douglas Valley, Forth St. Paul's, Kirkfieldbank, Kirkmuirhill, Lanark: St. Nicholas, Larkhall: New, Larkhall: Trinity, Law, Libberton and Quothquan, Newmains: Bonkle, Newmains: Coltness Memorial, Overtown, Shotts: Calderhead Erskine, Stonehouse: St. Ninian's, Strathaven: Avendale Old and Drumclog Memorial, Strathaven: Trinity, Symington, Upper Clyde, Wishaw: Cambusnethan North, Wishaw: Cambusnethan Old, Wishaw: Old, Wishaw: South, Wishaw: St. Mark's with a total allocation of 16 FTE Ministry posts.
- II. Representatives from the cited congregations were invited to make representations.

Parties were removed.

It was moved, seconded and agreed-

 - a. Note that the Kirk Session and Congregational Board approved the Draft basis of Dissolution;
 - b. Note that at a meeting held on 10 August 2023 18 out of 105 members of the congregation voted upon the basis of Dissolution with 17 members voting for and one voting against the Draft basis of Dissolution;
 - c. Approve the Draft Basis of Dissolution for the congregation of Cleland (Appendix 1).
- 3. Further to the decision made on 17 June 2023 to progress towards the Dissolution of the congregation of Carriden
 - a. Note that the Kirk Session approved the Draft basis of Dissolution;
 - b. Note that at a meeting held on 14 August 2023 45 out of 325 members upon the basis of Dissolution with 25 members voting for the basis of Dissolution and 20 voting against;
 - c. Approve the Draft Basis of Dissolution for the congregation of Carriden (Appendix 2).
- 4. Further to the decision made on 17 June 2023 to progress towards the Dissolution of the congregation of Larkhall: Trinity
 - a. Note that the Kirk Session and Congregational Board declined to approve the Draft basis of Dissolution:
 - b. Note that at a meeting held on 16 August 2023 29 out of 125 members and adherents voted for or against the basis of Dissolution with 14 members voting for the basis of Dissolution and 15 voting against;
 - c. Approve the Draft Basis of Dissolution for the congregation of Larkhall: Trinity (Appendix 3).

Parties were recalled and the decision of Presbytery intimated to them.

The Moderator thanked the members of the cited congregations for attending. Dr Paterson remarked on the difficult days ahead in the congregations and assured them of the prayers of Presbytery and led the Presbytery in prayer.

Report of Mission Plan Action Group to Presbytery on 2 September 2023

I. Context

- a. At the meeting of Presbytery in June 2023, the Mission Plan Action Group in consultation with the Clerks were instructed to make arrangements to draw up, consult on and agree the draft basis of Dissolution with Kirk Sessions and Congregations of Cleland, Carriden and Larkhall: Trinity.
- b. Significant work has been undertaken by the Group throughout the summer months and meetings have taken place to discuss the various draft Bases with the relevant parties. This was not an easy process and nor did it produce everything a Kirk Session or congregation desired would happen with funds and property at the point of dissolution given both the civil and ecclesiastical legal constraints that are in place for dealing with a dissolution.
- c. In determining that a congregation should be dissolved the Mission Plan Action Group have discussed a number of different options with congregations and the road to dissolution is never the first road embarked upon, and it is never the easiest. The Mission Plan Act Code of Practice (CofP) states that when developing a plan due regard should be paid to the principles of community presence (CofP 5.3.2), ecumenism (CofP 5.3.3), the poor (CofP 5.3.4), the whole people of God (CofP 5.3.5), mixed economy of church (CofP 5.3.6), financial responsibility (CofP 5.3.7) and buildings (CofP 5.3.8). The Mission Plan Action Group are aware that these three dissolutions are being sought as 'exceptions' to the plan due to Presbytery not yet having an approved Presbytery Mission Plan in place but even so have considered how the principles contained in the Act and Code of Practice might be answered.

2. Cleland

- a. The Kirk Session of Cleland contacted the Presbytery to seek permission to dissolve some time ago. The congregation has not regrouped after Covid lockdown and the building remains closed. The congregation is, for the most part, worshipping in the linked parish of Wishaw: St. Mark's. A union was considered however the desire of the Kirk Session to dissolve and allow the congregation to move to whichever church they chose, and release the few congregational trustees that remain for further duties and burdens was recognised and affirmed.
- b. The Mission Plan Action Group recognise the request from the Kirk Session for the congregation to be dissolved and as such have sought to ensure that the principles contained within the Mission Plan Act Code of Practice have been considered. The Mission Plan Action Group feel that the dissolution of Cleland is appropriate given the circumstances and reflects the presbytery's commitment to the Presbytery Mission Planning Code of Practice by
 - i. ensuring that there are numerous neighbouring Church of Scotland congregations that would continue to engage with communities, the poor, and congregation members of the current charge, (CofP 5.3.1, CofP 5.3.3, CofP 5.3.5).
 - ii. ensuring that there is significant Ecumenical provision within the local area to ensure varied worship resource for members and adherents, including several who offer a style of worship similar to that currently expressed by the charge, (CofP 5.3.2, CofP 5.3.4).
 - iii. ensuring that there is significant national and local provision (within the denomination and ecumenically) of a mixed economy approach to mission and worship which may be of some use to members of the dissolved congregation, (CofP 5.3.6).
 - iv. recognising that the charge is not financially sustainable currently, and ensuring that any possible burdens on the funds of the Church of Scotland are remedied, (CofP 5.3.7).
 - v. recognising that the congregation's ecclesiastical building has remained closed for 3 ½ years and the congregational trustees do not feel the building is suitable to reopen with the limited human and financial resources available and therefore acknowledge that there is no realistic opportunity of it opening as a place of worship and mission, (CofP 5.3.8).
- c. The draft Basis of Dissolution was drawn up in consultation with the Kirk Session and Congregational Board who voted in favour of the Basis. This was presented to the congregation at a meeting held on 10 August 2023 at which 18 out of 105 members voted for or against the basis of Dissolution. At that meeting 17 members voted for the basis of Dissolution and one voted against.
- d. The Mission Plan Action Group recommend that Presbytery approve the Draft Basis of Dissolution (Appendix I) and request that the General Assembly through the Presbytery Mission Plan Implementation Group approve the same.

3. Carriden

- a. The Kirk Session of Carriden had been engaged in discussions to create a united parish of Bo'ness along with Bo'ness: Old and Bo'ness: St. Andrew's. The former Presbytery of Falkirk held numerous meetings and votes with the Kirk Sessions but sadly the Kirk Session of Carriden withdrew from the union discussions and felt unable to lead their congregation into a united charge with the buildings decisions that had been taken. Significant engagement with the Kirk Session took place and it was the Kirk Session who asked Presbytery to consider dissolution, in order that they could take some control of the trajectory in which the congregation was heading and ensure that members did not feel forced into accepting a union they could not support. The Kirk Session still accept the decision they took some time ago that the appropriate missional shape for the Church of Scotland in Bo'ness is to have one single united congregation.
- b. The Mission Plan Action Group recognise the request from the Kirk Session for the congregation to be dissolved and as such have sought to ensure that the principles contained within the Mission Plan Act Code of Practice have been considered. The Mission Plan Action Group feel that the dissolution of Carriden is appropriate given the circumstances and reflects the presbytery's commitment to the Presbytery Mission Planning Code of Practice by
 - i. ensuring that there are numerous neighbouring Church of Scotland congregations that would continue to engage with communities, the poor, and congregation members of the current charge, (CofP 5.3.1, CofP 5.3.3, CofP 5.3.5).

- ii. ensuring that there is significant Ecumenical provision within the local area to ensure varied worship resource for members and adherents, including some who offer a style of worship similar to that currently expressed by the charge, (CofP 5.3.2, CofP 5.3.4).
- iii. ensuring that there is significant national and local provision (within the denomination and ecumenically) of a mixed economy approach to mission and worship which may be of some use to members of the dissolved congregation, (CofP 5.3.6).
- iv. recognising that the charge is not financially sustainable currently, and ensuring that any possible burdens on the funds of the Church of Scotland are remedied, (CofP 5.3.7).
- v. recognising that the congregation's ecclesiastical buildings would not feature in the plans of the united charge, ensure of their disposal at an early date, (CofP 5.3.8).
- c. The draft Basis of Dissolution was drawn up in consultation with the Kirk Session who voted in favour of the Basis. This was presented to the congregation at a meeting held on 14 August 2023 at which 45 out of 325 members voted for or against the basis of Dissolution. At that meeting 25 members voted for the basis of Dissolution and 20 voted against.
- d. The Mission Plan Action Group recommend that Presbytery approve the Draft Basis of Dissolution (Appendix 2) and request that the General Assembly through the Presbytery Mission Plan Implementation Group approve the same.

4. Larkhall: Trinity

- a. The Kirk Session of Larkhall: Trinity have worked with the Mission Plan Action Group to find a solution to where the congregation might fit within the Presbytery Mission Plan. Despite local conversations with numerous congregations within and outwith the community the Kirk Session were unable to enter into a cluster with other congregations to begin the process of planning. The Mission Plan Action Group offered further congregations to consider to which the Kirk Session declined to take forward. It is a matter of deep regret that local relationships have diminished so much between the Church of Scotland congregations that conversations on future planning could not even reach a point of beginning.
- b. The Kirk Session informed the Mission Plan Action Group that they felt the building could be transferred to a local trust (not yet established) to take over ownership and maintenance and allow the congregation to still worship and remain active. The Mission Plan Action group further invited the Kirk Session to submit a fully costed and realistic business plan for how this might work in practice. When a plan was submitted it was principally uncosted and did not move the conversation on significantly enough to convince the Mission Plan Action Group that Larkhall: Trinity could remain a viable, financially sustainable congregation of the Church of Scotland and therefore invited Presbytery to move to dissolution.
- c. The Mission Plan Action Group recognise the request from the Kirk Session for the congregation to be dissolved and as such have sought to ensure that the principles contained within the Mission Plan Act Code of Practice have been considered. The Mission Plan Action Group feel that the dissolution of Larkhall: Trinity is appropriate given the circumstances and reflects the presbytery's commitment to the Presbytery Mission Planning Code of Practice by
 - i. ensuring that there are numerous neighbouring Church of Scotland congregations that would continue to engage with communities, the poor, and congregation members of the current charge, (CofP 5.3.1, CofP 5.3.3, CofP 5.3.5).
 - ii. ensuring that there is significant Ecumenical provision within the local area to ensure varied worship resource for members and adherents, including some who offer a style of worship similar to that currently expressed by the charge, (CofP 5.3.2, CofP 5.3.4).
 - iii. ensuring that there is significant national and local provision (within the denomination and ecumenically) of a mixed economy approach to mission and worship which may be of some use to members of the dissolved congregation, (CofP 5.3.6).
 - iv. recognising that the charge is not financially sustainable currently, and ensuring that any possible burdens on the funds of the Church of Scotland are remedied, (CofP 5.3.7).
 - v. recognising that the congregation's ecclesiastical buildings would not feature in the plans of the united charge, ensure of their disposal at an early date, (CofP 5.3.8).

- d. The draft Basis of Dissolution was drawn up in consultation with the Kirk Session and Congregational Board. The Mission Plan Action Group were asked to give the Kirk Session further time to consider the draft basis. This was granted and after a meeting of local parties held on 8 August 2023 after which the Session Clerk in an email stated "The Session of Trinity has met and discussed your proposed Basis of Dissolution. You may now issue to the Congregation." It was assumed that this meant the Kirk Session had voted in favour however on the evening of the congregational meeting the representative from MPAG discovered that the Kirk Session had not in fact approved the draft basis, rather they had refused so to do and leave it to the congregation to decide. The representatives from the Mission Plan Action Group resolved to continue with the meeting and report the matter to MPAG. Accordingly, the draft Basis of Dissolution was presented to the congregation at a meeting held on 16 August 2023 at which 29 out of 125 members and adherents voted for or against the basis of Dissolution. At that meeting 14 members voted for the basis of Dissolution and 15 voted against.
- e. The Mission Plan Action Group discussed the issues of non-approval of both the local trustees and the congregation and after prayerful consideration still propose that the appropriate missional outcome for the congregation of Larkhall: Trinity is to be dissolved. Therefore, the Mission Plan Action Group recommend that, despite the vote against the Basis of Dissolution by the congregation, that Presbytery approve the Draft Basis of Dissolution (Appendix 3) and request that the General Assembly through the Presbytery Mission Plan Implementation Group approve the same.

Appendix I (2 September 2023)

Basis of Dissolution of the Congregation of Cleland Parish Church of Scotland, SC017084

- 1. **Act of Dissolution:** The congregation of Cleland Parish Church of Scotland, SC017084 shall be dissolved as at a date to be appointed by the Presbytery of Forth Valley and Clydesdale.
- 2. **Territorial Responsibility:** The area of the parish shall be transferred to the parish of Wishaw: St. Mark's, or as the Presbytery shall determine.
- 3. **Pastoral Oversight:** Prior to dissolution the Kirk Session shall provide the Presbytery Clerk with a list of the names and addresses of communicant members and shall issue to each such member a Certificate of Transference. Notices of Removal shall then be served by the Presbytery Clerk to the Ministers of the parishes of residence of the said members, with an instruction to provide due pastoral care.
- 4. **Heritable Property:** The interests of the congregation in the shared manse of the Charge of Cleland linked with Wishaw: St. Mark's at 3 Laburnum Crescent, Wishaw, ML2 7EH, with titles vested in the General Trustees, shall be surrendered at the date of dissolution and transferred to the congregation of Wishaw: St. Mark's (or its successor congregation). The titles of Cleland Parish Church, Bellside Road, Cleland, ML1 5NP are vested in the General Trustees who are authorised and empowered:
 - a. to sell, let or otherwise dispose of the said Church at such price or consideration and on such terms as may be approved by the General Trustees in consultation with the Presbytery of Forth Valley and Clydesdale; and
 - b. to transfer the free proceeds of such sale or let, subject to the meeting of any shortfalls of contributions to central funds which the Presbytery has determined to be unjustified (so far as these are not met from the funds referred to in Section 5 hereof) into the Central Fabric Fund.
- 5. Moveable property: A Committee consisting of the Craig Mains (Session Clerk), John Rundell, Mary McLean and Bert Dempster from the Congregation nominated by the Kirk Session prior to the date of dissolution, together with the Presbytery Treasurer, Presbytery Finance Sub Group Convener (or appointee) and Presbytery Property Sub Group Convener Presbytery (or appointee), is hereby appointed and vested with the power to deal with the whole furniture, furnishings and corporeal moveable property effeiring to the congregation. Isobel Miller shall act as a substitute member of the committee should any congregational member be unable to continue as a member of the Committee. The Presbytery Clerk, Depute Presbytery Clerk and Presbytery Buildings Officer will be ex-officio members of the Committee.
 - a. The said Committee shall have power to make over, in terms appearing appropriate to them (including by way of gift), any moveable property to other congregations or agencies of the Church of Scotland, any surplus items being sold and the proceeds being dealt with as in paragraph 5(b).
 - b. The said Committee is also hereby vested with the power to settle any debts due by the Congregation, including the meeting of any shortfalls of contributions to central funds, and to deal with the whole cash, funds in bank and marketable securities belonging to or effeiring to the Congregation.

- All such property will be realised and the net proceeds, under deduction of any debts, shall be gifted to the Presbytery of Forth Valley and Clydesdale (SC0486680) and designated as a new Fund to be entitled 'The Cleland Fund'. The said Fund will be administered by the Presbytery of Forth Valley and Clydesdale for the purposes of supporting Children's Ministry within the wider Wishaw area.
- c. The said Committee shall also be responsible for depositing all records relating to Cleland Parish Church of Scotland with the Principal Clerk of the General Assembly for onward transmission to the National Archives of Scotland.
- 6. **Endowments:** The endowments of the charge, if any, shall be transferred to the National Stipend Fund.
- 7. Assets held in Investors Trust: Any unrestricted funds held shall be included in Section 5(b) above.
- 8. **Restricted Funds:** Terms and Conditions of restricted funds, if any, shall be examined to ascertain the final destination of assets.

Appendix 2 (2 September 2023)

Basis of Dissolution of the Congregation of Carriden Parish Church of Scotland, SC007811

- 1. **Act of Dissolution:** The congregation of Carriden Parish Church of Scotland, SC007811 shall be dissolved as at a date to be appointed by the Presbytery of Forth Valley and Clydesdale.
- 2. **Territorial Responsibility:** The area of the parish shall be transferred to the parish of Bo'ness: St. Andrew's, or as the Presbytery shall determine.
- 3. **Pastoral Oversight:** Prior to dissolution the Kirk Session shall provide the Presbytery Clerk with a list of the names and addresses of communicant members and shall issue to each such member a Certificate of Transference. Notices of Removal shall then be served by the Presbytery Clerk to the Ministers of the parishes of residence of the said members, with an instruction to provide due pastoral care.
- 4. **Heritable Property:** The titles of Carriden Parish Church, Carriden Brae, Bo'ness, EH51 9LU; Blackness Church, St Ninians Way, Blackness, EH49 7NF; and the Manse at The Spires, Foredale Terrace, Bo'ness EH51 9LW are vested in the General Trustees, whilst the titles of the Church and Hall (known as the Mission and Lund Halls), Cowdenhill Road, Bo'ness, EH51 9JH are vested in local Trustees. Prior to the date of dissolution, the local Trustees shall transfer the title of the Church and Hall (known as the Mission and Lund Halls) to the General Trustees who are authorised and empowered:
 - a. to sell, let or otherwise dispose of the said Churches, Halls, and Manse, all at such prices or considerations and on such terms as may be approved by the General Trustees in consultation with the Presbytery of Forth Valley and Clydesdale; and
 - b. to transfer the free proceeds of such sale or let, subject to the meeting of any shortfalls of contributions to central funds which the Presbytery has determined to be unjustified (so far as these are not met from the funds referred to in Section 5 hereof) into the Central Fabric Fund.
- 5. **Moveable property:** A Committee consisting of Catherine Hamilton (Session Clerk), Graham Blackbourn (Treasurer) and Robert Stuart from the Congregation nominated by the Kirk Session, together with the Presbytery Treasurer, Presbytery Finance Sub Group Convener (or appointee) and Presbytery Property Sub Group Convener Presbytery (or appointee), is hereby appointed and vested with the power to deal with the whole furniture, furnishings and corporeal moveable property effeiring to the congregation. Florence Vance and Elspeth Anderson shall act as substitute members of the committee should any congregational member be unable to continue as a member of the Committee. The Presbytery Clerk, Depute Presbytery Clerk and Presbytery Buildings Officer will be ex-officio members of the Committee.
 - a. The said Committee shall have power to make over, in terms appearing appropriate to them (including by way of gift), any moveable property to other congregations or agencies of the Church of Scotland, any surplus items being sold and the proceeds being dealt with as in paragraph 5(b).
 - b. The said Committee is also hereby vested with the power to settle any debts due by the Congregation, including the meeting of any shortfalls of contributions to central funds, and to deal with the whole cash, funds in bank and marketable securities belonging to or effeiring to the Congregation.
 All such property will be realised and the net proceeds, under deduction of any debts, shall be applied in the following ways:
 - i. 50% of the total amount will be gifted to the Presbytery of Forth Valley and Clydesdale (SC0486680) and restricted as a new Fund to be entitled 'The Carriden Fund' with the capital being invested and the revenue expended annually for a period of ten years whereafter capital sums can be distributed. The said Fund will be administered by the Presbytery of Forth Valley and Clydesdale for the purposes of supporting Youth Work in

- Bo'ness with preference given to projects focussing on the Eastern part of Bo'ness within the former parish of Carriden within the Presbytery area;
- 30% of the total amount will be gifted by way of charitable donation to the work of The Church of Scotland Social Care Council, operating as CrossReach (Registered Charity SC011353);
- iii. 20% of the total amount will be gifted to the Presbytery of Forth Valley and Clydesdale (SC0486680) and designated as a new Fund to be entitled 'The Carriden (Welfare) Fund'. The said Fund will be administered by the Presbytery of Forth Valley and Clydesdale for the purposes of supporting Food Security and Welfare in Bo'ness.
- c. The said Committee shall also be responsible for depositing all records relating to Carriden Parish Church of Scotland with the Principal Clerk of the General Assembly for onward transmission to the National Archives of Scotland.
- 6. **Endowments:** The endowments of the charge, if any, shall be transferred to the National Stipend Fund.
- 7. **Assets held in Investors Trust:** Any unrestricted funds held shall be included in Section 5(b) above. Terms and Conditions of restricted funds, if any, shall be examined to ascertain the final destination of assets.

Appendix 3 (2 September 2023)

Basis of Dissolution of the Congregation of Trinity Parish Church of Scotland, Larkhall, SC008611

- 1. **Act of Dissolution:** The congregation of Trinity Parish Church of Scotland, Larkhall, SC008611 shall be dissolved on the 30th day of June 2024.
- 2. **Territorial Responsibility:** The area of the parish shall be transferred to neighbouring parishes as the Presbytery shall determine.
- 3. **Pastoral Oversight:** Prior to dissolution the Kirk Session shall provide the Presbytery Clerk with a list of the names and addresses of communicant members and shall issue to each such member a Certificate of Transference. Notices of Removal shall then be served by the Presbytery Clerk to the Ministers of the parishes of residence of the said members, with an instruction to provide due pastoral care.
- 4. Heritable Property: The titles of the Church and Halls at 96 Union Street, Larkhall, ML9 IEF and the Cottage at 96 Union Street, Larkhall, ML9 IEF shall be transferred to the General Trustees, who are authorised and empowered:
 - a. to sell, let or otherwise dispose of the said Church, Halls and Cottage at such price or consideration and on such terms as may be approved by the General Trustees in consultation with the Presbytery of Forth Valley and Clydesdale, noting that the desire and affirming the rights of, the Kirk Session to transfer the asset of the Cottage at 96 Union Street, Larkhall by way of charitable donation or sale, to the current occupiers prior to the date of dissolution; and
 - b. to transfer the free proceeds of such sale or let, subject to the meeting of any shortfalls of contributions to central funds which the Presbytery has determined to be unjustified (so far as these are not met from the funds referred to in Section 5 hereof) into the Central Fabric Fund.
- 5. **Moveable property:** A Committee consisting of 3 members of the Congregation nominated by the Kirk Session prior to the date of dissolution, together with 3 members nominated by Presbytery, is hereby appointed and vested with the power to deal with the whole furniture, furnishings and corporeal moveable property effeiring to the congregation. The Kirk Session will nominate 2 further members of the congregation to replace any of the original 3 nominees should they be unable to continue as members of the Committee.
 - a. The said Committee shall have power to make over, in terms appearing appropriate to them (including by way of gift), any moveable property to other congregations or agencies of the Church of Scotland, any surplus items being sold and the proceeds being dealt with as in paragraph 5(b).
 - b. The said Committee is also hereby vested with the power to settle any debts due by the Congregation, including the meeting of any shortfalls of contributions to central funds, and to deal with the whole cash, funds in bank and marketable securities belonging to or effeiring to the Congregation.

 All such property will be realised and the net proceeds, under deduction of any debts, shall be applied
 - in the following ways:
 - i. 10% of the total amount will be split equally and gifted by way of charitable donation to the Presbytery of Forth Valley and Clydesdale (SC0486680) and restricted as a new Funds to be entitled '1st Larkhall Boys' Brigade Fund' and '1st Larkhall Girls' Brigade Fund' to be used to

- support the work of the Ist Larkhall Boys' Brigade and Ist Larkhall Girls' Brigade or their successors.
- ii. 10% of the total amount will be gifted by way of charitable donation to the New Ministers' Furnishing Loan Fund (Registered Charity SC011353)
- iii. 80% of the total amount will be gifted to the Presbytery of Forth Valley and Clydesdale (SC0486680) and restricted as a new Fund to be entitled 'The Larkhall: Trinity Fund'. The said Fund will be administered by the Presbytery of Forth Valley and Clydesdale for the purposes of Community Support within Larkhall and surrounding area.
- c. The said Committee shall also be responsible for depositing all records relating to Trinity Parish Church of Scotland, Larkhall with the Principal Clerk of the General Assembly for onward transmission on to the National Archives of Scotland.
- 6. **Endowments:** The endowments of the charge, if any, shall be transferred to the National Stipend Fund.
- 7. **Assets held in Investors Trust:** Any unrestricted funds held shall be included in Section 5(b) above.
- 8. **Restricted Funds:** Terms and Conditions of restricted funds, if any, shall be examined to ascertain the final destination of assets.
